Participants are responsible for their selling spaces.  
Before leaving, all rented spaces must be clean and trash-free

#### Staffing

Vendor spaces must be manned at all times and intact until the event concludes. The Plaquemines Community Development Group and Plaquemines Parish Government is not responsible for merchandise or displayed items.

#### Participant Responsibility

The Plaquemines Community Development Group and Plaquemines Parish Government expressly disclaims any responsibility for same.
